#### **Required Documents to exercise the Warrants**

### **Payment Method**

The Warrant Holders can make payment for the Exercise of BTC-W6 from 9.00 a.m. to 3:30 p.m. (or within the business hours of each branch of Bangkok Bank Public Company Limited) between 27 June 2024 to 11 July 2024 (only on Business Day) or from 9:00 a.m. of 27 June 2024 to 3:30 p.m. of 11 July 2024 as the case may be. The methods are as follows:

- 1. Payment via the Bill Payment System of Bangkok Bank Public Company Limited, by using the Bill Payment Form (Enclosure 2) and completing the necessary information and specifying the Warrant Holder reference code (Ref.1), the ten-digit Warrant Holder registration number (as shown in the Certificate of Warrant Entitlement issued by Thailand Securities Depository Co., Ltd. (the "TSD")), and the reference code (Ref.2), the thirteen-digit ID card number or passport number of the Warrant Holder. Payment for the exercising warrant shall be made at the service counter of Bangkok Bank Public Company Limited (all branches). In the case of making payment by cheque, draft, or cashier's cheque, these must specify the date during 27 June 2024 8 July 2024 only, and the payment must be made via the service counter of Bangkok Bank Public Company Limited by the bank's clearing time on 8 July 2024, with payment made to "Bualuang Securities Public Company Limited for Share Subscription", and these must be able to be collected by the clearing house located in the same area by the next business day. In the case that the Warrant Holder makes payment after the clearing time on 8 July 2024, the Warrant Holder must make payment by cash or money transfer via Bill Payment System only. In this regard, payment fees will be exempted for Warrant Holder who make payment via the Bill Payment System of Bangkok Bank Public Company Limited; or

- 3. Money Transfer via Mobile Banking channel of Bangkok Bank Public Company Limited. The Warrant Holder can make payment via Bualuang Mobile Banking ("Bualuang mBanking") by scanning QR code shown on exercising process screen via <a href="www.bualuang.co.th">www.bualuang.co.th</a> (the Warrant Holder reference code (Ref.1) which is the ten-digit Warrant Holder registration number and reference No. (Ref.2) which is 13-digit ID number or passport number will automatically show on the screen). Or the Warrant Holder can make a payment by filling in service code "ROBLS01", then filling in required information by stating the 10-digit Registration No. in Ref.1 (Registration No. as stated in the Certificate of Warrant Holder Entitlement issued by TSD) and stating 13-digit ID number or passport number in Ref.2, and filling in desire payment. Warrant Holder is required to check information of payment transaction then save and/or print payment evidence for further subscription process (The Warrant Holder information will based on information of Ref.1 and Ref.2 in payment detail only).
- 4. Money Transfer via Mobile Banking channel of other Banks. The Warrant Holder can make payment via other banks' mobile banking application by scanning QR code shown on exercising process screen via <a href="www.bualuang.co.th">www.bualuang.co.th</a> (the Warrant Holder reference code (Ref.1) which is the ten-digit Warrant Holder registration number and reference No. (Ref.2) which is 13-digit ID number or passport number will automatically show on the screen), then filling in required information by stating the 10-digit Registration No. in Ref.1 (Registration No. as stated in the Certificate of Warrant Holder Entitlement issued by issued by TSD) and stating 13-digit ID number or passport number in Ref.2, and filling in

- 5. Money Transfer via Automatic Transfer System ("ATS") channel, this channel supports Warrant Holder who has a securities trading account with Bualuang Securities Public Company Limited and has request money transfer via ATS. The payment via ATS will effective on or before the exercise period (The Warrant Holder can inform their intention to their investment consultant ("IC"), or via E-Exercise system). This channel is only entitled for the warrants deposited with Bualuang Securities Public Company Limited.
- 6. Payment by cash deduction from a securities trading account with Bualuang Securities Public Company Limited (The Warrant Holder may inform their IC of their intention, or via the E-Exercise system).

## **Exercising Procedures**

The Warrant Holder can exercise from 9.00 -15.30 hours of 27 June 2024 to 11 July 2024 (11 business days in total) or from 9:00 a.m. of 27 June 2024 to 3:30 p.m. of 11 July 2024 as the case may be, by the procedures as follow:

- 1. The Warrant Holder who already made payment must submit payment evidence along with other required documents at headquarter of the Agent Receiving Exercise Intention at Bualuang Securities Public Company Limited. All documents must not be submitted at counter at any branch of Bangkok Bank Public Company Limited; or
- 2. The Warrant Holder can exercise his/her warrant via Online (E-Exercise) channel via www.bualuang.co.th by following the instruction below.
  - 2.1 The Warrant Holder can check their entitlement via <a href="www.bualuang.co.th">www.bualuang.co.th</a> (in the event that there was no rights certificate issued by TSD) by filling in ID number
    - In case of Warrant Holder has right to exercise, the system will display and enable to further process.
    - In case of Warrant Holder has no right to exercise, the system will display "Your information not found"
  - 2.2 The Warrant Holder will see his/her registration number (or Ref.1 for payment)
  - 2.3 Complete the form. The Warrant Holder can scan QR code shown on the screen for payment via Internet Banking, Mobile Banking or bill payment system at any branch of Bangkok Bank.
  - 2.4 Review and recheck the information and confirm the payment transaction, then save and/or print evidence of the payment for further process.

3. For individual Warrant Holder who has a trading account with Bualuang Securities Public Company Limited, he/she may exercise BTC-W6 via recording phone call with his/her IC. IC will proceed with the E-Exercise on their behalf in accordance with the procedures and methods prescribed by Bualuang Securities Public Company Limited (the "Phone Call Subscription"). The Warrant Holder must provide verbal confirmation in the Phone Call Subscription system in relation to the address of Warrant Holder, educational background, disclaimers warning in respect of the warrant exercise as set out in the system for subscription via <a href="www.bualuang.co.th">www.bualuang.co.th</a>. In this regard, once the IC receives confirmation with the details of the Phone Call Subscription, the order must be recorded through a system prepared by Bualuang Securities Public Company Limited. The system will display the details of the Phone Call Subscription, comprising IC's name, date of transaction and recording time in the system.

#### Remarks:

- (1) Transaction fee for payment via Bill Payment System of Bangkok Bank Public Company Limited will be waived.
- (2) The Warrant Holders must not make the payment or issue cheque before the period for the notification of intention to exercise the Warrants mentioned above.
- (3) The Warrant Holders who make the payment via Bill Payment System of Bangkok Bank Public Company Limited must submit a copy of the Bill Payment Form and documents for the notification of intention to exercise the Warrants to Bualuang Securities Public Company Limited. Please do not submit such documents at any branch of Bangkok Bank Public Company Limited.

In this respect, the exercise of rights to purchase the ordinary shares shall be considered complete only when the Company and/or the Agent Receiving Exercise Intention have successfully collected the payment of such exercise. If the Company and/or the Agent Receiving Exercise Intention could not collect such payment in whatsoever case that is not due to the fault of the Company and/or the Agent Receiving Exercise Intention, the Company will consider that such Warrant Holder intends to cancel his/her respective intention to exercise the rights to purchase the ordinary shares. In exercising the rights to purchase the newly issued ordinary shares of the Company, the Warrant Holders may exercise their rights under the Warrants to purchase the newly issued ordinary shares either in whole or in part. For any outstanding Warrants that are not exercised, the Company will deem that the holders of such outstanding Warrants do not wish to exercise their rights thereunder, and such Warrants shall be deemed as being nullified without having been exercised.

However, the Company, at their discretion, reasonably allow the Warrant Holder to exercise his or her right under the warrant.
